Abbreviations after each animal or handler's entry indicate additional classes in which that animal is entered. H indicates a Halter class, F or M or N indicates Female, Male or Non-Breeding; L or M or H indicates Light, Medium or Heavy Fibre; J, Y or A indicates Juvenile, Yearling or Adult. Thus HFLJ would be Halter Female Light Fibre Juvenile. F1, F2, FS indicate a Fleece class, first, second or subsequent shearings. VY, CA indicates a Costume class, Youth or Adult handler. OL1, OL2, OL3 indicates Obstacle Level One, Two or Three. PL1, PL2 indicates Pack Level One or Two. SJ, SI, SS, SA indicates a Showmanship class, Junior, Intermediate, Senior, or Adult handler. VERS indicates an animal/handler team entered in several different classes and thus eligible for MOST VERSATILE LLAMA. YVERS indicates that the animal/dandler team is eligible for YOUTH VERSATILITY.

HALTER CLASSES

- LIGHT FIBRE:** minimal body fibre, short neck fibre, smooth head, legs and ears. Llama is judged on balance, structure, movement and type.
- MEDIUM FIBRE:** moderate to long body fibre, minimal to moderate neck fibre, smooth to moderate head, leg and ear fibre. Llama is judged on balance, structure, movement, type and 20% on fibre quality.
- HEAVY FIBRE:** abundant fibre on body, neck, head, ears and legs. Llama is judged on balance, structure, movement, type and 20% on fibre quality.
- JUVENILE:** llama at least 5 months old but not yet 12 months.
- YEARLING:** llama at least 12 months old but not yet 24 months.
- ADULT:** llama at least 24 months old.

PERFORMANCE CLASSES

QUALIFYING: llamas must earn at least 70/100 points, and at least half of the available points for each obstacle in order to qualify. Qualifying scores earn "legs" towards titles. Both Qualifying and Non-Qualifying scores are eligible for prizes.

LEGS: the numbers in brackets after each animal's information (0/3) indicates how many of the three necessary "legs" that animal has toward that title

LEVEL ONE: llamas which have not earned a Level One title in the particular sport (Obstacle or Pack) are eligible to compete. Three qualifying scores under two different judges are necessary to earn the title, Obstacle Level One (OL1) or Pack Level One (PL1).

LEVEL TWO: llamas which have earned a Level One title are eligible to compete in Level Two in that particular sport. Three qualifying scores under two different judges are necessary to earn the title Obstacle Level Two (OL2) or Pack Level Two (PL2).

LEVEL THREE: llamas which have earned a Level Two title are eligible to compete in Level Three in that particular sport. Three qualifying scores under two different judges are necessary to earn the title Obstacle Level Three (OL3). Pack Level Three (PL3) is currently under construction.
